What is Parenting After Divorce?

According to U.S. News & World Report, 60% of all two year olds will end up in a single parent household before age 18.

Children of divorcing parents experience emotional disruption and trauma, not only at the time of divorce, but for several years afterward. While all parents want to help their children survive the divorce emotionally intact, few parents receive helpful information about the pitfalls and conflicts to avoid.

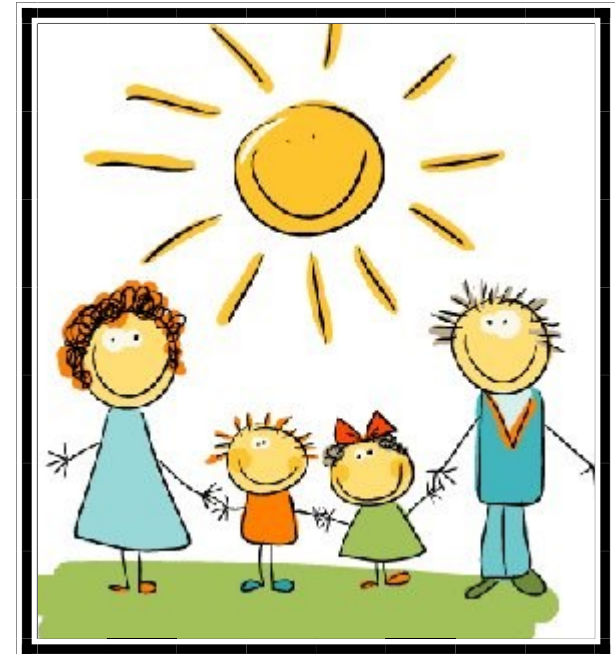
For those families going through lengthy court battles, the healing process is delayed for both adults and children. Parents often feel bitter and distrustful of each other and may have difficulty communicating without animosity.

Divorcing parents **will not** be scheduled to attend the same class. A confirmation email and postcard will be sent verifying the location, date and time of the class. All group classes will be held from 6:00pm to 7:30pm, on the First and Third Tuesdays of each Month. In some circumstances, schedule conflicts may warrant a private class. These are available at the discretion of our Moderators and require an addition fee.

COSTS

All costs for classes must be paid **in full** before attendance. Moderators are not allowed to take payment on the evening of class.

ATTENDANCE IS REQUIRED TO RECEIVE A CERTIFICATE

Each parent is required to attend one session lasting approximately 1 and 1/2 hours. No certificates will be given until after parent has completed the course. If you are unable to

attend your scheduled appointment or in case of inclement weather, contact Melody at 573-686-4873. Due to limited class size, a one week notice is required to receive a refund. You must arrive on time to receive credit for attendance. **Latecomers will be turned away.** Sessions will involve several methods of instruction and class discussion. A resource packet and a handbook will be distributed to each parent. After attending the class a certificate of completion will be given to the parent, and a certificate will be sent to the appropriate court.

DO NOT BRING UNREGISTERED ADULTS TO CLASSES!

Class moderators have been directed to turn away any person who is not a confirmed, pre-registered participant. Please understand that this restriction is for the protection of all class participants.

DO NOT BRING CHILDREN!

There are no facilities at the classroom site for children. The subject material in the instruction and class discussion does not provide a suitable environment for children, regardless of how well behaved they might be. If you cannot find someone to watch your children, please reschedule your class date. Parents who bring children to class will not be allowed to participate.
